40/22 APOLOGIES FOR ABSENCE

To receive and accept apologies for absence RESOLVED, proposed by Cllr Clarke, seconded by Cllr Capozzi to accept the apologies of absence received from Cllr Somervail for the reasons stated in his email. Unanimously agreed.

Further to item 36/22 a. in the minutes of 5th September 2022, the Clerk will be arranging a zoom meeting for later in October for all councillors to attend a briefing of the contents of the EMR presentation so they have time to consider

the proposals and come to the formal EMR FC meeting in November with comments and thoughts.

44/22 REPORT FROM BOROUGH/COUNTY COUNCILLORS

To receive a report from Borough/County Councillors. Report from County Cllr Douris

- a. The proposal to formalise the crossing on A4251 is pending. However, C/Cllr Douris noted that this would be a protracted process and he could not give an indication of what the outcome might be.
- b. Cllr Somervail had indicated the possibility of having a pedestrian crossing on the New Road, however, he has since expressed that New Road may not be an appropriate place for a crossing.
- c. Herts County Council recently had an LGA Peer Review with both elected members and senior officers from other authorities to look at what HCC does and how well it performs. As it involved representatives from HAPTC he anticipated that there would be feedback due to the course to HAPTIC.
- d. C/Cllr Douris, upon a request from Cllr Pringle through the Chair, undertook to ascertain the current status of the outcome of the Motion at Hertfordshire County Council in 2018 with regard to the traffic and safety issues following a petition presented at that meeting.

C/Cllr Douris left the meeting at this point.

Report from Borough Cllr Pringle

a. The St Mary's Primary School governor with responsibility for travel safety has contacted me to ask for support with the school's bronze travel plan. They wish to have a co-ordinated approach. I have explained that HCC passed a motion to review road safety in Northchurch in 2018, which has yet to be implemented, and that we should co-ordinate with HCC as well as the Go20 group and the NPC road safety working group to ensure that we have the best plan for our residents. My aim is to get an engineer from HCC to visit Northchurch to view the ground.
